Operationalizing Perinatal Equity, Quality and Safety in Materno-toxic Zones - Every Person, Every Time.

Materno-toxic Zones - As defined by the National Perinatal Task Force (NPTF), a materno-toxic area is any area where it is unsafe to be pregnant, breastfeeding or parenting. An area might be unsafe because of a physical threat to health, freedom or thriving in an environment. Or it might be unsafe because of the psychological and social pressures a person feels when in that environment – ridicule, judgment or anxiety might all play a role. Historically, people in materno-toxic areas traditionally face birth outcomes that are worse than those in adjacent areas and suffer an increased risk for premature birth, low-birth weight, and infant and maternal morbidity and mortality. Additionally, we recognize that the toxicity of implicit and explicit biases, racism, classism and sexism is created wherever a pregnant woman of color or marginalized person may be, and as such the materno-toxic status is not always just because of a specific geographic location. Regardless of where or how the toxicity shows up, the lack of perinatal safety impacts their chances of a healthy birth outcome.

Jennie also describes the impact of structural, historical and institutional harm experienced by the providers, practitioners and stakeholders leading to the vicarious trauma, moral injury and burn-out experienced by those of us on the frontlines of this movement to reclaim our humanity. Materno-toxicity affects us all!

## **Putting it into Practice**

This presentation furthers our collective goals of eliminating perinatal disparities and provides readily-implemented tools and tweaks that will empower providers and stakeholders alike. The model is easily adaptable to telehealth with some creativity and a focus on communication and what we call 'gap management', and leads to a deeper understanding of the ways we can collaboratively and effectively move towards improved maternal/infant health and better birth outcomes for all communities.
